The “Brest” FEZ territory comprises 15 main areas located in Brest, Pinsk, Baranovichi, Kobrin and Gantsevichi.



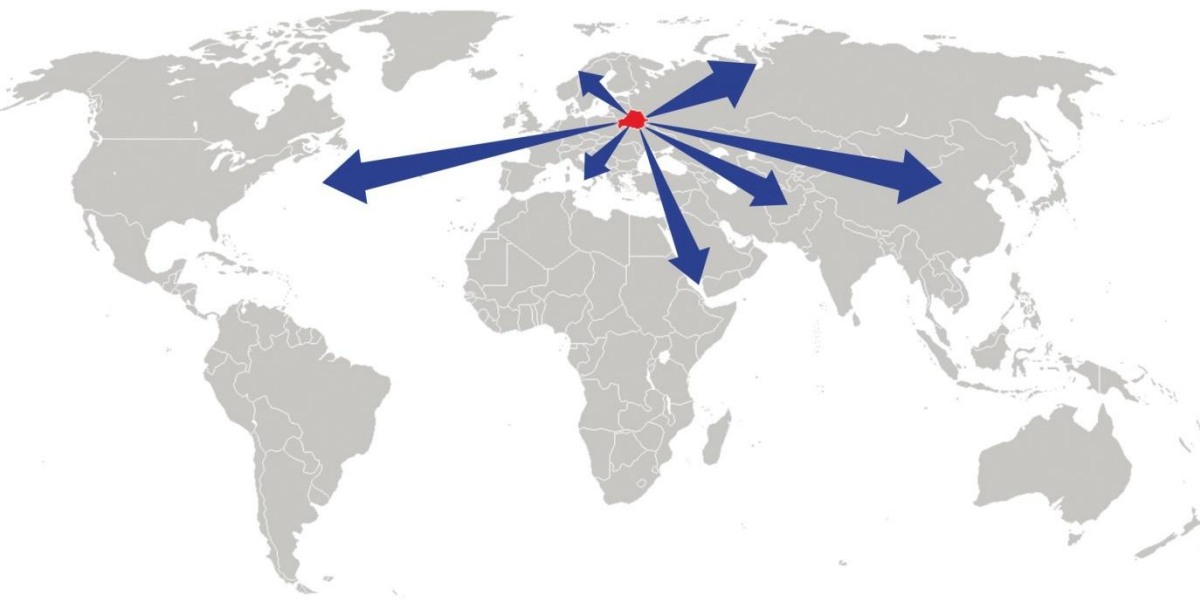

Taxes Exemptions

The profit of FEZ residents received from sale of goods of own manufacture within the special legal regime (for export, to other FEZ residents), is exempt from the income tax

FEZ residents are exempt from the tax on the real estate.

The land parcels of FEZ residents located in the FEZ borders are exempt from the land use tax and a rent payment.



FEZ residents do not pay the import VAT for imported goods used for production purposes within the declared investment project.

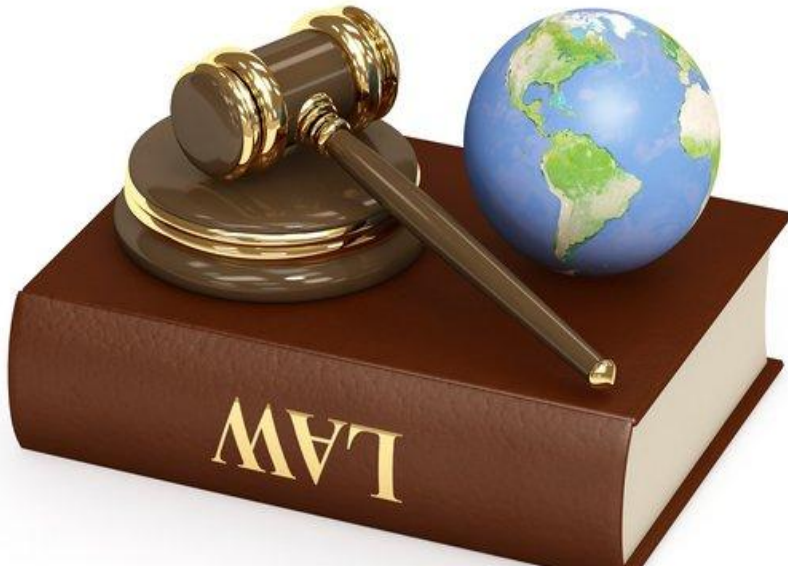
The equipment and building materials, imported to the FEZ territory by a company-resident for implementation of an investment project are not cleared and the customs VAT is not levied.

If produced goods are sold to countries located outside the Euroasian Economic Union the customs duties on imported raw materials are not levied.



Additional preferences:

- Land parcels for FEZ residents are provided without carrying out an auction.
- Residents are exempt from mandatory sale of foreign currency.
- There are available highly qualified personnel of working and technical specialities.





The “Brest” FEZ Administration:

- conducts procedures of state registration of economic entities and zone residents;
- renders assistance in solving problem issues on government and municipal levels;
- represents your interests and backs your projects;
- consults in legal, customs and fiscal issues;
- grants on lease land plots and assists in the production spaces selection for lease when looking for a place for your business.
